MAIN ACTIVITY

Civil Society Programme at the 2022 EBRD Annual Meeting

Our long-anticipated 2022 Civil Society Programme took place in a hybrid format on 10-12 May 2022, as part of the EBRD's Annual Meeting and Business Forum in the vibrant city of Marrakech, Morocco. The event attracted around 200 civil society representatives.

The Programme consisted of two dedicated sessions between civil society organisations (CSOs) and the Board of Directors and the EBRD President, an open panel focusing on how partnerships between governments, the private sector and civil society can foster a more inclusive and peaceful future, and a civil-society-led open panel focusing on civil society in sustainable energy transitions. Similarly to 2021, the Programme featured a session on the Bank's Independent Project Accountability Mechanism. This year, the Programme also included a session on the Bank's independent Evaluation Department.

The meetings with the Board and the EBRD President allowed CSOs to engage in a constructive dialogue and present issues of concern and recommendations on key strategic themes and operations of the Bank. The Board, as well as the EBRD President, recognised the importance of working together with CSOs to achieve greater impact.

The Programme also featured a multi-stakeholder panel focused on building partnerships between civil society, government and the private sector. The panel looked into how partnerships, coordination and alignment between entities can foster new opportunities for growth and impact. Panellists were from MasterCard, the Disasters Emergency Committee, Oxfam and the Sawiris Foundation.

This year's event also featured a CSO panel led by E3G that looked into the role of civil society and MDBs in the context of sustainable energy transition. Representatives from E3G, the EBRD, the Moroccan Alliance for Climate and Sustainable Development and the High Atlas Foundation sat on the panel, along with other climate experts. <image>

Enhancing inclusive and sustainable development

In late May, Olena Koval, head of the Civil Society Engagement and Private Sector Partnerships team, attended the first CSO Forum of the Islamic Development Bank. The panel participants shared their insights from their respective organisations on the importance of CSOs in attaining the Sustainable Development Goals, and how partnerships with CSOs can help MDBs achieve their mission through sustainable development interventions.

While the Covid-19 pandemic posed additional challenges to the functioning of governments, markets and communities, it also highlighted the importance of digitalisation. During the pandemic we increased our dialogue with civil society stakeholders to better understand their needs and challenges due to the crisis. Under our Civil Society Capacity Enhancement Framework, we started to increase CSOs' digital capacity and address ICT skills gaps with our civil society digital transformation programme.

The war on Ukraine has also shown the importance of civil society actors, both in responding to the humanitarian crisis and documenting war crimes. Their role will come into its own during the reconstruction phase once the war is over. In Ukraine, working and supporting civil society's resilience and sustainability is also vital to the EBRD's work. We started to work with various CSOs to support the coordination efforts and to address specific aspects of the crisis.

Both crises demonstrated that partnerships with CSOs should be at the core of MDBs' work on the ground, and civil society should be an equal actor to the private sector when it comes to policy development. We are committed to working with our MDB colleagues to mainstream civil society engagement as well as partnerships with CSOs across our regions.

CSO engagement workshops

In June we organised several workshops in Istanbul, Ankara and Tbilisi as part of the "Capacity Building Project for Stakeholder Engagement in the Covid-19 Crisis and Beyond", piloted in Georgia and Turkey. The goal of the project is to build the capacity of EBRD clients so they can operate effectively with communities, and to train and equip community liaison officers (CLOs) so that they can initiate trust and open dialogue between EBRD clients and community representatives, thus increasing the potential for better development outcomes from Bank-financed projects.


The workshops were a key milestone in the development phase of training materials and techniques, and the start of the roll-out and testing of the toolkit and e-learning modules will guide CLOs towards transparent, inclusive, sincere and communications-focused engagement.

As part of the EBRD's efforts to support equal opportunities for women and men in the automotive manufacturing sector, we facilitated a workshop in the Sekerpinar industrial zone. During the workshop, we discussed gender equality with the Turkey Automotive Suppliers Association (TAYSAD) and its members, while the participant companies drafted their companies' gender equality action plans. As a result of the EBRD's support, we are looking forward to the first-ever gender strategy for the automotive supply industry in Turkey.

EBRD 2022 Literature Prize

EBRD Literature Prize Winner 2022



The Orphanage, a novel written by Serhiy Zhadan and translated from Ukrainian by Reilly Costigan-Humes and Isaac Stackhouse Wheeler, has won the 2022 EBRD Literature Prize.

Set in contemporary eastern Ukraine, the book, which was published by Yale University Press, is a raw, compelling story of a civilian's desperate journey through conflict zones to reach home.

The EBRD Literature Prize was created in 2017 by the EBRD in cooperation with the British Council. It recognises the best work of literary fiction originally written in a language from the EBRD regions and translated into English, and which is published by a UK or a Europe-based publisher. As EBRD President Odile Renaud-Basso explained, "the Bank not only invests in changing lives across its regions, but it also engages with the cultural traditions of these countries, as we are an institution that strives to make a positive impact beyond economics".

The $\leq 20,000$ prize is split between the author and translator.

The two runner-up titles received €8,000, also split between writer and translator. These were *The Book of Katerina* by Auguste Corteau, translated from Greek by Claire Papamichail (Parthian Books); and *Boat Number Five* by Monika Kompaníková, translated from Slovak by Janet Livingstone (Seagull Books).

This is now the fifth year of the EBRD Literature Prize.

JP Morgan Corporate Challenge
